Upon full payment of the tour price by the tour participant (“you” or “your”) named in the Reservation Application agreement (“application”) 2 Getaway Travel, 18002 Moss Point Dr. Spring, TX 77379, (“We, Us, 2GT, MM and SET”) agrees to provide the services specified in the accompanying advertising subject to the terms, conditions and limitations contained in this agreement. This agreement shall be effective when the Application is properly completed, signed and payments therein specified are received and accepted by us. If we do not receive your completed Application, We cannot include You on the tour. Neither You, representatives, nor Your travel agent may modify, add, or delete any terms of this agreement.

Deposits – must be made at time of confirmation, deposit amount is a minimum of \$250 per person on Land Only and charter reservations. Scheduled air reservations require a deposit equal to or greater than the cost of the air to be determined at time of confirmation of your reservation.

Payments - All checks are made payable only to 2 Getaway Travel LLC. Final payments must be made 60 days prior to the beginning date of the trip. Any person that makes a reservation within 60 days of the beginning day of the trip must pay in full. We cannot be responsible for reservations when final payments are not received on time, in which, the cancellation policy will be in effect. All penalties are per person. All cancellations must be made in writing. Cancellation policy will be in effect if payments are not received on time or written cancellation notice is not received by 2GT, MM and SET. 2GT, MM and SET is not responsible for lost payments or delay in mailing. Cancellation by phone must be confirmed in writing by fax or mail within 3 days from the person that cancels. See Substitution for refund options.

Revision Policies:

Name Changes will incur a \$25 per change fee plus any airline fee/hotel fees. Any changes to reservations after they have been deposited will incur a \$25 per person revision fee plus any fees that may be assessed by the airline or the resort.

Party South of the Border DVD recording: Recording, photography, or video taping of activities during the entire 2GT, MM and SET Party South of the Border including but not limited to all scheduled Party South of the Border performances and activities in venues, public areas, lodging properties, and any location deemed necessary for recording, photographing, or videotaping that may be conducted for future re-broadcast, advertising, or commercial purposes. By participating in the said trip and or entering any South of the Border venues or areas noted, you are consenting to these activities without payment or remuneration of any kind.

Returned Checks - 2GT, MM and SET shall collect a \$30.00 charge for any returned checks. The \$30.00 returned check fee plus the original amount of the check must be paid to 2GT, MM and SET within 72 hours of your verbal or written notification by 2GT, MM and SET or your reservation will be canceled. Amount due must be paid by money order, cashier's check, or certified check.

Collection Cost -Participant agrees to pay reasonable attorneys fees and other expenses incurred by 2GT, MM and SET in the collection of unpaid damages, insufficient or stopped checks, credit card reversal or misrepresentation or other losses under this agreement if such collection is deemed necessary by 2GT, MM and SET.

Participants Requested Changes - All requests for any changes that deviate from the advertised trip must be received in writing by 2GT, MM and SET.
